Article VI, Section 8: Order of Business

Article VI, Section 11: Leaving Meeting

"Members of the State Council shall not leave the business meetings portion of the convention without permission of the presiding officer. Violators of this section shall be subject to the forfeiture of all mileage and per diem. The State Deputy or the presiding officer may require a roll call at any time to determine that all delegates are present."
